<p><b>What is the overall <a href="#">deductible</a>?</b></p>	<p>In-Network: \$600 individual/\$1,000 family; Out-of-Network: \$1,000 individual/\$2,000 family</p>	<p>Generally, you must pay all the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family member(s) on the <a href="#">plan</a>, each family member may need to meet their own individual <a href="#">deductible</a>, OR all family members may combine to meet the overall family <a href="#">deductible</a> before the <a href="#">plan</a> begins to pay, depending upon plan coverage. Please refer to your contract for further details.</p>
<p><b>Are there services covered before you meet your <a href="#">deductible</a>?</b></p>	<p>Yes, all In-Network preventive care services, as well as the following (non-hospital facilities only, when applicable): Emergency room and Urgent care</p>	<p>This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. <p><b>Will you pay less if you use a <a href="#">network provider</a>?</b></p>	<p>Yes.
